RDA E-SAFETY POLICY



INTRODUCTION

The aim of Riding for the Disabled Association (RDA) is to provide disabled people with the opportunity to ride or carriage drive, to benefit their health and well-being. The Member Groups provide disabled people with opportunities to join in social activities, competitions, or residential experiences - which combine to bring a new dimension to necessarily restricted lives, encourage independence and do much to improve a wide range of medical conditions.

RDA is committed to providing a safe and enjoyable environment for children, young people and adults at risk. All children, young people and adults at risk have a right to be safe and protected from harm.

INTERNET SAFETY POLICY STATEMENT:

- RDA recognises its responsibility to safeguard the welfare of all children, young people and adults at risk, by protecting them from all forms of abuse which can occur through the use of electronic communications.
- RDA is committed to meeting this obligation by affording the highest level of care for children, young people and adults at risk through its safeguarding procedures.
- This policy applies to anyone within RDA, whether those persons be in a paid or volunteer capacity, or as part of a competing team or volunteer/supporting group. This also includes trustees, members of the committee/board and designated medical and veterinary staff.
- RDA accepts that the use of the internet, electronic communications and social media is an
 intrinsic part of everyday life and can present challenges in terms of how it is used
 responsibly. RDA recognises that through misuse, all forms of electronic communications
 can be actually or potentially harmful to others.

OBJECTIVES

RDA has a responsibility to ensure that its activities are free from abuse and to ensure that it has put into place adequate measures to safeguard all involved from harm. This includes highlighting poor practice.

This Policy sets the following objectives:

- To ensure that Groups implement a code of conduct for all forms of electronic communications that is applicable to all involved with the organisation
- To ensure that all paid staff, committee/board members, trustees, physiotherapists, volunteers, competitors and support groups of the Group are aware of their duty and of the process to report any incident of alleged abuse or poor practice relating to electronic communications.

RDA E-SAFETY CODE OF CONDUCT FOR RDA VOLUNTEERS



RDA understands the importance of emerging technologies for education, personal development and social interaction. However, we also recognise that safeguards need to be in place to ensure everyone using these electronic communications is kept safe at all times.

RDA seeks to promote e-safety by:

- Supporting and encouraging the use of electronic communications in a way that keeps everyone safe and shows respect to others.
- Supporting and encouraging parents and carers to do what they can to keep their children or vulnerable people safe when on-line or using their mobile phone.
- Informing parents and carers of incidents of concern as appropriate, dealing firmly, fairly and decisively with any examples of inappropriate use.
- Ensuring that images of children, adults at risk or vulnerable people and families are used only after permission has been obtained and for the purpose for which consent was given.

Whilst a lot can be gained from anyone using electronic communications, RDA requests the following guidance be followed during or involving RDA activities:-

Always

- Accept that there is a duty of care to all children and vulnerable people.
- Use electronic communications in an open and honest manner and conduct yourself as you
 would in face to face communications.
- Separate your personal and RDA social networking identities, by setting up a separate RDA account.
- Ensure your personal networking profile is set to private or friends only.
- Choose your profile picture with care.
- Ensure you have the required permissions when uploading photos and videos online.
- Copy in a colleague when communicating with any RDA participant or anyone under the age
 of 18.
- Report any concerns to your Group Safeguarding Officer

Never

- Accept electronic communications with anyone under the age of 13.
- Accept friend requests on your personal account from anyone over whom you hold a position of trust.
- Use your personal social network account to communicate with anyone over whom you hold a position of trust.
- Post derogatory or malicious comments or use inappropriate language.
- Engage in a one-on-one conversation via chat or instant messaging facilities.

- Deliberately browse, download or upload material that could be offensive or illegal.
- Give out details such as address, phone number or location unless they are separate professional contact details.
